### July Outreach

- In July the RFL hosted 0 programs and meeting space for 0 meetings. Attendance in these events included 0 children and 0 adults.
- On July 1<sup>st</sup> the latest edition of the Roxbury Newsy was mailed to the community.
- The RFL tennis program had 3 families enroll this year. Though consistent with turnout last year, the number of participants is lower than it was about five years ago.
- At the end of July we updated our wi fi network. The changes included adding a landing page to the
  network when someone connects to it. We will now also be able to accurately track how many people
  connect to the network. During August we expect to setup the rest of the extended network so that we will
  be able to provide wi fi service to all of downtown Roxbury.

#### Miscellaneous

- Jane Pincus coordinated the annual RFL bake sale on July 4th.
- The RFL was closed for 4 of the 5 Tuesdays during the month of July. I will update the board about the details of those unexpected closures during the board meeting.
- Contractor Bill Langely had been scheduled to begin the final phase of the ramp repair work the
  last week of July but had to delay his start due to a personal injury. I will notify the board when
  the work actually begins hopefully within a few weeks.
- I do not have a start date for the entryway project but hope to see it begin around the end of August.
- VTDOL is officially in their new location housed within the VT. Historical Society in Barre. As of last week it sounds like phones, internet, and services are largely up and running.
- Fall 2018 will mark the first school year that the Montpelier Roxbury School District operates. Last winter the director of the Kellogg Hubbard library in Montpelier and I discussed what the new school district means for our abilities to serve the children of the district. We worked out a plan that will allow Roxbury children attending school in the Montpelier facilities to have access to a Kellogg Hubbard library card for no fee. The staff at the Kellogg Hubbard were proactive and supportive of the change to the school community and helping to ensure Roxbury children would have equal access to Kellogg Hubbard services while in the city.











## July 2018 By the Numbers: **Roxbury Free Library**



**VISITS** 



#### New & Updated Laws Passed by the VT Legislature in 2018

Several new and updated laws were passed in the 2017-2018 legislative session, and a few of those laws affect the work of public libraries.

Three laws specifically to look at:

- Gender Neutral Bathrooms (H.333 "An act relating to identification of gender-free restrooms in public buildings and places of public accommodation"):
   https://legislature.vermont.gov/assets/Documents/2018/Docs/ACTS/ACT127/ACT127%20Act%20Summary.pdf Any public restroom with a single stall/toilet must be "made available for use by persons of any gender." Bathrooms designed with multiple stalls or for multiple users can still be labeled for one gender.
- Job Applicants and Questions about Past Compensation (H. 294 "An act relating to inquiries about an applicant's salary history"): <a href="https://legislature.vermont.gov/assets/Documents/2018/Docs/ACTS/ACT126/ACT126%">https://legislature.vermont.gov/assets/Documents/2018/Docs/ACTS/ACT126/ACT126%</a> <a href="20Act%20Summary.pdf">20Act%20Summary.pdf</a> This law prohibits employers from asking "a prospective employee's current or past compensation, requiring that a prospective employee's compensation satisfy certain criteria, or determining whether to interview a prospective employee based on his or her current or past compensation."
- Open Meeting Law There were a few updates/clarifications to Vermont's Open Meeting Law, including:
  - o adding a definition to the Open Meeting Law and clarifying what activities do not constitute a meeting under the Open Meeting Law
  - establishing when a series of less-than-a-quorum communications to or among members of a public body is prohibited under the Open Meeting Law.

  - o Details:
    - Updated definition of "business": "business of the public body' means the public body's governmental functions, including any matter over which the public body has supervision, control, jurisdiction, or advisory power."
    - Updated definition of "meeting": "'Meeting' shall not mean a gathering of a quorum of a public body at a duly warned meeting of another public body, provided that the attending public body does not take action on its business."
    - Another updated definition of "meeting": "'Meeting' shall not mean occasions when a quorum of a public body attends social gatherings, conventions, conferences, training programs, press conferences, media events, or otherwise gathers, provided that the public body does not discuss specific business of the public body that, at the time of the exchange, the participating members expect to be business of the public body at a later time."
    - Another updated definition of "meeting": "'Meeting' shall not mean any communication, including in person or through e-mail, telephone, or teleconferencing, between members of a public body for the purpose of scheduling a meeting, organizing an agenda, or distributing materials to discuss at a meeting, provided that... no other business of the public body is discussed or conducted."
